- Reviewed Fall 2022 Spring 2024 Danielson evaluation data for Residency I, Residency II & MAT Student Teaching candidates. MAT candidate scored lower overall in all domains, compared to residency I & II candidates. All indicators improved from residency I to residency I for undergraduate candidates

2.SIBME – Melissa Goodson

3. Teacher Education Program (TEP)

- Review of TEP admission rates and denial factors for Fall 2016 to Spring 2024, taking into account the changes in Basic Skill criteria.
- Basic Skills prevented TEP admission for 89% of candidates (only issue, or combined with other factors) prior to Fall 2023
- Basic Skills no longer hinders program admission. 93% of applicants are now at least provisionally admitted.
- Of students denied, 65% never re-applied, or were never admitted. Please encourage students to re-apply during advising, and make sure they are ready
- We will copy advisors on TEP candidates who have been denied so they can be aware
- Review admission requirements more heavily and immediately with transfer students

4.Basic Skills

- Candidates must meet Basic Skills criteria in Reading, Writing & Math prior to Residency I admission.
- Review of Basic Skills data at time of TEP admission. Data was disaggregated by content area and demographics.
- Fall 2023 Spring 2024 data

o Reading/Writing

- secondary majors didn't use course grades, they utilized SAT and/or ACT exams. Elementary majors relied heavily on course grades
- 0 applicants used Praxis Core
- 1st generation college students and students who were not low income met criteria at a higher rate

o Math:

- Applicants primarily utilized course grades (68%), with secondary and elementary majors going this route
- 0 applicants used Praxis Core
- 1st generation college students and students who were not low income met criteria at a higher rate

5.Enrollment

- Enrollment data from 2016-17 thru 2024-25 was reviewed
- Online elementary has drastically increased, and continues to do so. It has almost surpassed in-person elementary
- Education major enrollment is down 45% since 2016-17. Non-Education major enrollment is down 27% since 2016-17. Campus wide enrollment is down 31%
- Graduate programs campus wide are down 28% since 2016-17. MAT program enrollment is down 81%. M.Ed. Full Program enrollment is down 57%, with certificate programs down 67%. It was noted when cohorts were present, to account for increased in M.Ed. enrollment.

6.Demographics

- Demographics of undergraduate & graduate students for 2019-20 to 2023-24 were reviewed.
- Education has a drastically larger percentage of female students compared to other majors
- Education has a lower percentage of non-white students compared to other majors
- Education majors have higher percentage of low-income students and 1st generation students compared to other majors

7.TPA

- IRR training for WVTPA 5.0 next meeting. Please score sample TPA before meeting (in SharePoint)
- TPA data was reviewed.
- Students struggle with:
 - narratives
 - Task 6 --- what does this all mean?
 - Task 4 --- How does data impact teaching?
- Compare 4.0 & 5.0 data to see if there are improvements
- Summarize mini-TPA to compare with full TPA, especially online elementary majors
- Summarize raw data to obtain overall task averages

8. Recruitment Goals

- Can generate data analysis (generalized & deeper dives)

- Faculty were asked to score a sample WV TPA 5.0 prior to this meeting. Scores were reviewed for IRR to ensure at least 80% agreement in all tasks. If task was not 80% agreement, scoring was discussed and re-scored until 80% was achieved in all areas.

- 2 failed Praxis II content attempts and a 3.0 content GPA are required for the waiver
- Elementary majors must pass the Teaching of Reading exam (TRE) to qualify for the waiver. There is no flexibility with this.
- TRE and Content Knowledge Exams (7000 elementary series) take 4-6 weeks to be scored

1. Residency I Praxis II attempt policy

- Fall Residency I: exam(s) must be attempted by June 30th. Scores must be received by August 1st
- Spring Residency I: exam(s) must be attempted by 1st Friday in November. Scores must be received by 2nd Friday in December
- Remind students to list CU as a score recipient. If not, they must pay \$50 to have them resent. If scores are resent, ETS sends the highest attempt, not the most recent attempt

2.EPPAC Meeting Summary

- Reviewed consistent themes of 'speed dating' responses:
 - Students need to experience multiple early clinical experience placements. Beginning Fall 2025, the following will be implemented in response:
 - Students can't go to the same school for all 3 early clinical experiences; they can go to same school for 2 out of 3 early clinicals
 - Secondary & Special Education majors cannot complete clinicals at the high school they graduated from
 - \circ Lack of confidence & accountability

3.F.EB. Meeting – Dr. Williams

- Change of schedule for when student evaluations are completed. Currently, evaluations are due last day of class. It has been suggested to have evaluations due last day of finals week, or due the week before the last day of class.
- Our department prefers the week before last week of class

4. Residency Praxis I hours

- CU's Residency I program hour requirement is significantly higher than WVDE Policy 5100 requires. CU requires roughly 400 hours; WVDE requires 250 hours. Andrea proposed modifying Residency I schedule from 4 placement days to 3 placement days (Monday, Tuesday, Wednesday). Thursdays will be utilized for coursework. Fridays can be a flex day for classroom prep, substituting, lesson planning, studying, make-up time etc.
- Adam Coon motion to change residency I to 3 days per week (Monday, Tuesday, Wednesday) for 14 weeks. William Williams seconded. Discussion followed on how to handle exceptions and how this would limit/impact supervision visits.
- Adam Coon re-motioned. William Williams seconded. All in favor.
- Discussed the 4 absence policy, and if we would need to clarify what Fridays were meant to be used for.
- This policy change will not be announced until Summer 2025.

5. TEP Admission: 75-hours working with youth

- Issues regarding 75-hour documentation have become apparent
- "Letterhead" requirement is not on the rubric, but it is in the portfolio directions.
- Letterhead seems to be getting increasingly difficult to come by du to so many different programs available.
- Dr. Williams advocated for keeping letterhead as part of the vetting process since it is difficult to forge/fake
- Department consensus is to keep letterhead. Portfolios will be denied if hours are not on letterhead. This will be added to the rubric for Spring 2025.

 - SPED content courses already align with online elementary courses. SPED majors would follow the same course rotation as online ELEM majors. The only new online course offerings would be the EDSP courses, BIOL101 & HIST102. BIOL101 & HIST102 currently have online options, but an official ON section would be needed.
 - Concern expressed for an online SPED program taking students from the online ELEM program, which would decrease online ELEM course enrollment.
 - Online program can be utilized for CAEP/CAPA recruitment goals to increase the number of licensed SPED teachers in WV
- Adam Coon motioned to accept new program, Anita Deck seconded, all in favor. Academic Council approval is next step.

3. Catalog change for Residency I

- Catalog change form for Residency I presented. Changes include reducing clinical days from 4 days per week to 3 days per week (Monday, Tuesday & Wednesday), and including a Praxis II attempt in admission requirements beginning Fall 25.
