NOTES:

- 1. The incentive budget shall be no more than 1% of total sub-award annually and must be pre-approved.
- 2. The above cost limits do not include tax (the project will not reimburse for taxes/must use tax free status where available for schools)
- 3. The above cost does not include shipping and handling but can be reimbursed on the same reimbursement form.
- 4. Anticipated expenditures must be detailed in the subaward/school's approved work plan and yearly budget.
- 5. iTunes or similar items are considered entertainment and are not an allowable expenditure.
- 6. Gift cards are not allowable.
- 7. Using funds for staff incentives is unallowable.



Food and beverages may be offered in conjunction with GEAR UP SWV structured activities where the participants are receiving GEAR UP SWV project information. Please find specific meal and beverage example guidelines below and note, these and all other expenditures must be detailed in the school's approved work plan and yearly budget.

Meals for field trips and college visits	We recommend that one meal per day be provided through the school food service to reduce costs.	Up to \$15 per student per meal (list students, staff, chaperones who eat must be turned in with reimbursement request) Meals provided by a college campus food service program will be reimbursed at full cost. Reimbursement is based on actual attendance. Staff/chaperone meals: Either the student meal allowance or the district per diem is allowable, not to exceed the state per diem.	
Snacks for field trips, college visits and testing	Healthy, nutritious snacks (granola bars, cheese, fruit, popcorn, trail mix, pretzels, crackers, milk, juice, yogurt, or muffins).	Up to \$3 per day per student.	
Celebratory events or activity for students	Up to 1 event per quarter for student recognition for special achievement (GPA, attendance, or GEAR UP SWV benchmark, etc.).	Up to \$1 per student per event.	
Student	A small treat/candy to encourage	Up to \$1 each per student per activity.	
Participation Incentive	participation such as returning a survey.	Exceptions may be made for special events outside of school hours, such as a pizza party for a National GEAR UP Week competition. Permission is required.

Student meals or snacks while on school grounds, during the school day.	Not allowable unless prior approval from GUSWV.	Food or snacks will not be approved for lunchtime activities.	

NOTES:

- 1. Events must be entered in the PI, Performance Insights, database to document participation PRIOR to the reimbursement being made.
- 2. The Reimbursement Request Form MUST INCLUDE the agenda for approved activity, list of attendees, list of participating staff, cost for registration/materials, and appropriate purchase orders.
- 3. Expenses that do not adhere to the above rules will NOT be reimbursed. Please do not ask for an exception.
- 4. Perishable leftover food from events should be sent home with GEAR UP SWV families and students whenever possible. In the event of excess, it can be distributed to GEAR UP SWV students at school the following day. If neither of these are possible, it can be donated to a local pantry. Non-perishable food should be kept for another GEAR UP SWV event.



GEAR UP allows expenses related to dual credit options, credit recovery, student camps and placement tests. When using GEAR UP SWV funds to pay these expenses, priority should be given to low-income students who do not have the family resources to pay for them. It is allowable to pay these expenses for GEAR UP SWV students if you have confirmed that family resources are not available. Use the following guidelines when planning for these expenses. Anticipated expenditures must be in the school's approved work plan and budget.

It is strongly recommended that you obtain permission from the GEAR UP SWV central office before booking a speaker. Anticipated expenditures must be detailed in the school's approved work plan and budget.
