  - Three new professors have been hired for three different departments.
  - Over the summer, all computers will be updated to Windows 11.
  - Security cameras have been either replaced or installed. There is the intention for security cameras to also be installed in every classroom. While all cameras have the capacity for facial recognition and audio detection, the only ones that will have facial recognition will be at the entrances/exits, and audio will be in the daycare. Only the campus police will always have access to every camera, but the daycare workers will have access to the daycare cameras, and residence workers will be able to have access to their respective systems. There will be 700 cameras campuswide.
