Minutes for meeting held Wednesday, November 5th, 2025

The meeting was called to order at 4:04 PM by President Abby Stovall. Attendance was taken and a quorum was established. The minutes for the meeting held on October 29th, 2025 were approved.

Special Order of Business:

- Dr. Meighen had to reschedule her address to the November 12th Senate meeting

Student Open Forum:

- There are extensive concerns about dining services on campus; **see pages for details, but summary of concerns is below:**
 1. Food safety and sanitation (gnats in the cafeteria are a specific problem right now, as well as dishware not being cleaned thoroughly)
 2. Food quality and variety (rotating weekly menus was given as a suggestion)
 3. Pricing and meal plan structure (number of meal exchanges allowed per day is limited)
 4. Hours of operation and late-night access (particularly an issue for athletes and people with night classes)
 5. Catering and event services (concern about safety; at recent Sober Halloween party, the pizza could not be eaten by children and pregnant women)
 6. Student health, nutrition, and inclusivity
- It was mentioned that waffle cones and bowls were taken away from the ice cream machine
- Outside food is not technically allowed at Aramark locations, and Aramark has a monopoly on campus food
- More student feedback is needed to improve food services; a survey is currently being circulated
- More nutritious food is needed for athletes and diabetics
- Suggestion was made to add a 24/7 “grab and go” food station
- There is a need for more meal plan options on-campus aside from the two (more FLEX dollars vs. meal swipes)
- Night classes forbidding dinner is particularly a problem for chemistry majors
- According to Aramark:
 - All staff are ServSafe certified
 - Food temperatures are checked frequently, and food is tossed out if there is an issue
 - Loss of waffle cones and bowls is temporary due to not having a proper closed container for them

- Staff stay behind to clean until 8 PM during the week
- Meal exchanges per day is not limited to one; there is a five-hour waiting period to ensure that people aren't getting food for other people
- Outside food is not permitted because of a contract between Aramark and the university
- Grab and go food stations were once stationed throughout campus before being moved to in front of the Fitness Center due to underutilization
- Aramark utilizes a dietitian
- **Concerns about dining are being forwarded to the Dining Services Director**

- Ms. Boblits addressed a concern suggesting that a locker room/shower area be placed by the Fitness center; after doing some research, she discovered that this existed previously
 - The cost to put this is beyond our scope right now, but can be looked into in the future
 - Issues with the Fire Marshall is also an obstacle
- Additional concerns will be addressed at the November 14th meeting

- The new recreation area will allow students to check out mountain bikes, pickleball/tennis equipment, basketballs; it will also include a mini golf course
- *Other suggestions for campus improvement are not dead!* They will be explored further in the spring and next fall
