Minutes for meeting held Wednesday, October 15th, 2025

The meeting was called to order at 4:01 PM by President Abby Stovall. Attendance was taken and a quorum was established. The minutes for the meeting held on October 8th, 2025 were approved.

Special Order of Business:

Student Open Forum:

- Campus is *very, very* hard to navigate if you are wheelchair bound; extensive specific issues were noted:
 - Wheelchair accessible entrances are only at the back of buildings, adding travel time
 - The only working elevator in the Student Center is a service elevator, which is not ideal and inconveniently placed
 - Elevators in the Science and Admin Buildings are far from entrances
 - It is difficult for a wheelchair to make it through the midsection of the Fine Arts Building (between Admin/Science and Carter) because of the doors, forcing users to either cut by the art wing (which has no sidewalk) or the music/health wing (which adds a significant amount of time)
 - The automatic door button on Carter doesn't work properly
 - Is there an elevator to get to the phys ed/health science classrooms on the second floor of Carter? If there is, it is REALLY well-hidden.
 - The automatic door button on the side of North Tower does not work at all; the front button doesn't work properly
 - The sidewalk from the Towers to Rahall forces wheelchair users to move into the road
 - The sidewalk from the Towers to Sarvey Hall/the Bonner House/Wilson Hall is too steep for most wheelchairs to make the trip
 - Many of the sidewalks on-campus are cracked and have missing pieces

Paddle Decoration Guidelines

Purpose:

- To allow organizations to creatively personalize their voting paddles while preserving professionalism, fairness, and reusability.

1. Paddle Integrity

- The paddle itself must not be permanently altered (no painting, carving, stickers, or adhesives directly on the paddle).
- Decorations must be created on a separate sheet of paper or cardstock that can be taped or clipped on and easily removed.

2. Size and Attachment

- The decoration sheet must not exceed the paddle's original dimensions (no overhanging edges).
- All decorations must be securely attached (tape or removable adhesive only—no glue, staples, or nails).
- Decorations should not interfere with legibility of the organization's name.

3. Content Standards

- All decorations must align with Concord University's values and SGA's code of conduct:
- Appropriate content only: No profanity, hate speech, sexual content, or discriminatory imagery.
- Positive representation: Designs should reflect school spirit, organization pride, or community engagement.

4. Identification Requirement

- The organization's name must remain clearly visible on the paddle or the decoration sheet.
- The name should be printed or written in legible, professional lettering.

5. Reusability

- Paddles must be able to return to their original condition after removal of decorations.

6. Approval & Enforcement

- SGA reserves the right to review and approve or deny designs prior to their first use in a meeting.

7. Deadlines

- If decorations are being reviewed, they must be submitted to the SGA email for approval at least 24 hours before the next voting session.
